#### PROFESSIONAL IDENTITY

Die Association of Swiss Inhouse Lawyers (Vereinigung Schweizerischer Unternehmensjuristen, VSUJ) is an association for legal professionals who practice law in Swiss companies and work for these companies. Since its establishment in 1982, a sense of professional identity has developed among Swiss corporate lawyers, which is continuously nurtured and built upon through the active participation of approximately 350 individual members and 30 corporate memberships with around 325 registered lawyers.

The objectives of the VSUJ are:

- Advocacy of professional interests
- Exchange of experiences
- Continuing education
- Fostering relationships among members

To uphold professional ethics, the VSUJ has established strict professional rules that members are obligated to adhere to.

### **ACTIVITIES**

The VSUJ regularly organizes events for its members. These events have a direct relevance to the profession. Speakers include renowned specialists from the legal profession, academia, business, administration, as well as members themselves.

The association offers its members interesting opportunities for professional exchange of experiences and casual networking with valuable contacts among professional colleagues.

The activities of the VSUJ include:

- Conferences featuring topics related to legal and non-legal activities of corporate lawyers in the form of presentations, seminars, or workshops
- Practice Groups for selected topics
- Annual general assembly with professional presentations and subsequent discussions
- Publication of an annually updated membership directory
